THE PARTIES HEREBY AGREE TO THE FOLLOWING:

1. Spokesperson(s) shall be Titus County residents.

2. Each organization shall submit to the City of Mount Pleasant at least **10 days prior to the beginning date** of the proposed usage dates the following:
 - A. Anticipated number of participants and teams.
 - B. Organization's Rules and ByLaws.
 - C. List(s) of current officers.
3. All weekday games are to be completely finished by 11:15 p.m. No inning shall begin after 11:00 p.m. **All lights will be turned off at 11:30 p.m.**
4. The City will act as the coordinator for the use and reservation of the above-mentioned fields. In this capacity, the City realizes the property involved is public and therefore will make every effort to ensure that the use of these fields is open to all parties without discrimination
5. Each organization shall be responsible for the purchase, supervision and maintenance of all equipment used such as bases, P.A. system, scoreboards, etc. To ensure safety, alterations in design or type of equipment may be required by the City of Mount Pleasant. Prior to installation, all bases used upon these facilities shall be approved by the City of Mount Pleasant.
6. The organization will be responsible for dragging the fields and marking lines as well as any other pre-game field preparation. The City will be responsible for the initial infield preparation and for mowing.
7. **The organization agrees that no modifications, alterations, changes or deletions (temporary or otherwise) may be made to any facility owned by the City unless written approval is obtained from the Parks Department and/or City Engineer.** All such improvements will become the property of the City.
8. The organization and the Mount Pleasant Police Department is responsible for the enforcement of designated parking areas. Violators may be towed at owners' expense.
9. The organization is responsible for the removal of trash and equipment from the playing field (inside the fences of each individual field), dugouts and concessions area after each tournament. The City of Mount Pleasant will be responsible for clean-up of remaining areas.

10. The league organization is responsible for supervision and control of persons attending athletic events. Unsportsmanlike conduct by players, coaches or spectators will not be allowed, and alcoholic beverages will not be allowed on park property. The organization will notify the Mount Pleasant Police Department should a disturbance occur.
11. All materials stored by the organizations for use on the fields (dirt, lime, etc.) shall be placed only in areas approved by the City of Mount Pleasant.
12. If at any time these guidelines are not met by the organization, the City reserves the right to revoke this agreement and privileges connected herewith.
13. In consideration for being permitted by the City of Mount Pleasant to utilize the athletic facilities, the League and its members and participants hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which may occur arising out of, or connected in any way with participation in activities with the organization at City sports facilities. It is further agreed to indemnify and to hold the City of Mount Pleasant free and harmless from any loss, liability, damage, cost, or expense which may be incurred as the result of death or any injury or property damage sustained while participating in activities at City sports facilities.

This agreement is meant to facilitate the effective use of City facilities. The City of Mount Pleasant wishes to express its appreciation to these organizations for the contribution each makes to this community. The City of Mount Pleasant pledges its support and cooperation to the organization represented herein.
